**NOTICE INVITING TENDER**

Sealed tender in prescribed form from contractors registered in appropriate class in CSPGCL / GOVT. DEPTT./PSU are invited for the following works :-in three part tendering system. The request of unregistered but having experience of similar works in Govt./ Public Sector Undertaking on submission of evidence as mentioned in Eligibility Criteria may also be considered.

**(1) Name of work :- Construction of 36 nos. 'F' type quarters i/c internal water supply and electrification at 2x500 MW Marwa TTPP (Tender Spn.No.EDC-Proj/2x500 MW-Marwa/W/2011/35 ).**

NIT value – ` 205.00 lacs, EMD – ` 2.05 lacs, Completion period – 15 months i/c rainy season, Class of contractor – A-V & above., Cost of Tender form – ` 1,000/-, Rate – Percentage rate above/ below/ at PAR of SOR of WRD (01.08.2010) including amendments upto the date of opening of price bid & base rates of NSOR items, last date for submission of application for tender form – 28.11.2011, Last date for issue of tender form – 29.11.2011, Last date for submission of tender form – 30.11.2011 Upto 4.00 P.M., Due date for opening of Technical & Commercial Bids – 30.11.2011 at 4.15 P.M.

**(B) Eligibility Criteria :-**

(i) Average annual financial turnover achieved by bidder in last three years statement certified by Registered Chartered Accountant should be at least ` 170.00 lacs. Bidders should submit audited reports alongwith balance sheets and profit & loss statement schedules for relevant financial year in which criteria for last three years as proof of above required turnover may be indicated therein. The applicant firm shall be a profit (net) making firm and shall not have made losses in last 2 financial years or any 3 out of last five financial years. A weightage of 5% compounded annually shall be given for equating the financial turnover and value of work completion (from the date of completion of work to the submission of bid) of the previous years to current year.

(ii) The bidders in his own name should have executed similar work during last 5 years ending on 31.10.2011 value of which should be not less than

(iii) The bidders shall have registration in EPF Deptt. and submit its proof.

(iv) For execution of similar civil works under Clause-(ii) a certificate from the Officer-in-charge not below the rank of Executive Engineer of concerned department about having executed the work satisfactorily indicating the name of work, description of work done by bidders, value of

contract executed by bidder, date of start, date of completion (contractual, actual) shall be submitted. In case of dispute the decision of undersigned shall be final.

**(C) Additional Informaton :-**

(1) The bidder should have his own or should have tie up arrangement for following minimum machineries/ equipments for which the contractor has to submit the relevent documents- 3 nos. Dumpers, 2 nos. 10/7 Cft. concrete mixer, 3 nos. watering pumps of assorted capacity 5 HP to 10 HP, 750 Sqm. Steel shuttering plate and form work/ scaffolding material, 1 no. compressive strength testing machine, Diesel Generator 100 KVA 1 no. piling equipments – 3 sets.

(2) Bidders should furnish information regarding projects in hand, technical manpower available, details of current litigation & arbitration cases, intimation regarding exclusion / expulsion or black listing, if any in prescribed format (Proforma 2).

(3) The bidder should be registered in Chhattisgarh Building and other construction worker welfare Board. In case the bidder is not registered, they have to submit undertaking that they will get done all necessary formalities as per prevailing rule in time in case contract is awarded to them.

**(D) GENERAL TERMS & CONDITIONS**

1. Tender document can be obtained from the Office of E.D..(Civil-Proj.), CSPGCL, Raipur on remittance of its prescribed cost i.e. ` 1,000/- only (non refundable) in the form of Demand Draft in favour of Assistant Manager (CAU), CSPGCL, Raipur or Postal Order. In case the document is required by post the cost of ` 75/- is to be paid extra alongwith cost of tender document. In case of postal delay, CSPGCL will not be responsible.

2. Completed tenders shall be submitted upto 16.00 Hrs. on the date specified i.e. 30.11.2011. First two parts i.e. Commercial bid and Technical Bid will be opened on 16.15 Hrs. on the same day. The Price Bid of the Bidders who qualifies the eligibility criteria will be opened on later date, which will be communicated to the bidders separately.

3. Executive Director (Civil-Project) on behalf of Company shall have right to either accept any of the bid or reject one or all the bids without assigning any reason.

4. Before submitting the offers the tenderers / bidders are advised / requested to visit the project site to get themselves fully acquainted to the actual site conditions and have complete information in respect of work.

5. In case the last date of sale of tenders and / or the due date of opening of tender happens to be a holiday, the last date / due dates mentioned above shall be automatically shifted to next working day for which no prior intimation shall be given.

6. In case of extension of due date of opening of tender, the tenders already submitted will be retained by this office. However, the bidders who have already submitted the bids will be allowed to submit fresh bids in a plain paper mentioning the item rates (in words and in figures), in a sealed envelop mentioning the reference of tender submitted earlier and the original & extended due date of opening of tender to reach this office within stipulated time and date. Original and subsequent fresh offer will be opened on the extended due date of opening and the

lowest will only be considered. In case fresh offer is not received, the original offer will be considered.

7. The price variation clause shall be applicable.

8. The applicants have to sign each page of all qualifying papers submitted by them. In case of dispute the decision of the undersigned shall be final.
