Sub: Allocation of officers & employees-Final Allocation of Shri SK Agrawal, the then Joint Director, MPEB.

Ref: Notification No 168 Dtd. 05.04.2008.

The Tentative Final Allocation List (TFAL) for the cadre of Asstt. Chief/ Joint Director was issued vide Notification referred above. In the said TFAL, Shri SK Agrawal (S.No.20) working with MPEB as Joint Director as on 01.11.2000 was shown as allocated to MP/ MPSEB. The last date for submission of representation against the allocation shown in said TFAL was stipulated as 08.05.2008.

Shri Agrawal, submitted a representation dtd. 06.05.2008 requesting for change in allocation from MP to CG. Subsequently, he filed an application dtd. 8.5.2008 for mutual transfer with Shri PVG Swami, Jt. Director, who was listed at S.No.2 of the said TFAL and was allocated to CG/ CSEB.

Shri Agrawal was informed that his case will be considered in 15<sup>th</sup> meeting of the Committee at Bhopal on 01.07.2008 and in case he wants to be heard by the Committee in person, he may appear in the said meeting at his own cost. He appeared before the Committee in the said meeting and also in the meeting held on 6<sup>th</sup> & 7<sup>th</sup> February 2009. The Committee considered his case on 07.02.2009 & observed that as Shri Agrawal had not submitted option for any particular State, his option was deemed to be made for MP in accordance with clause 2.8 of "Procedure of Allocation" & accordingly his allocation is made to MP/ MPSEB. His representation made for change in allocation is not acceptable in accordance with clause no. 8 of "Procedure of Allocation". His allocation made to MP/ MPSEB, therefore, is in order.

As regards, the application made by Shri Agrawal for mutual transfer with Shri PVG Swami was also not found in accordance with the relevant procedure laid out in "Procedure of Allocation".

Shri Agrawal again made a representation dtd. 16.02.2009 to the Committee. A representation dtd. 19.02.2009 was also received from Shri PVG Swami, wherein he had requested to issue his Final Allocation order to CG/ CSEB as per his option and TFAL. The matter, therefore, again considered by the Committee in the 20<sup>th</sup> meeting held in Raipur on 7.3.2009, wherein Shri Swami appeared in person and withdrew his consent for mutual transfer with Shri SK Agrawal through a written application, which has been taken on record. He has, also requested for issue of his final allocation order to CG/ CSEB. The Committee observed that the mutual transfer application of these two officers is no longer valid.

The allocation of Shri SK Agrawal, the then Joint Director to MP/ MPSEB is, therefore, now confirmed.
