Sub: Allocation of officers & employees-Final Allocation of Shri G.S.Jha, ED (Generation).
Ref: Notification No 412 Dtd.31-08-07.

The Tentative Final Allocation List (TFAL) for the cadre of ED (Generation) was published on vide Notification cited above. In the said TFAL, Shri G.S.Jha (S.No.04) has been allocated to MP/MPSEB.

Shri Jha submitted a representation before the Committee that in the earlier TFAL issued, he was allocated to CG/CSEB. Therefore, he be considered allocated to CG/CSEB only instead of MP/MPSEB shown in TFAL issued vide Notification Dtd.31.08.07. Shri Jha has been given due opportunity to appear before the Committee for personal hearing.

As Shri Jha did not appear before the Committee, his case has been considered in absentia. The Committee observed that Hon'ble High Court of CG in WP has withdrawn the Allocation Guidelines and TFAL issued earlier in compliance of the order Dt. 27-04-07 passed. No.6025/2006. The representation made by Shri Jha on that ground, therefore, can not be considered. His Allocation to MP/MPSEB is made in accordance with clause 2.3 of the "Procedure of Allocation" issued subsequently is in order.

The Committee, therefore, confirms the allocation of Shri G.S.Jha to MP/MPSEB. The said allocation, however, may be re-considered, if so required, on decision of Hon'ble High Court of CG in WP.No.1306/2002.
