Sub: Allocation of officers & employees-Final Allocation of Shri P.K.Jain, JE (Gen.).

The Tentative Final Allocation List for the cadre of JE (Gen.) working with MPEB as on 01.11.2000 was issued vide Notification referred above. In the said list, Shri P. K. Jain (S.No.213) has been allocated to "CG" in accordance with the option for "CG" State submitted by him.

Shri Jain, subsequently made a request for change in allocation from "CG" to "MP". The said request, however, was not found acceptable as per "Procedure of Allocation". Lateron, he again made a request for mutual transfer alongwith Shri Sabyasachi Banerjee, who, found to be belonging to the cadre other than that of Shri P. K. Jain. The mutual transfer request made, thus, was also not acceptable in accordance with the "Procedure of Allocation".

Shri Jain again made a request through the Chhattisgarh Power Generation Co. Ltd., (a successor Company of CSEB), that his mutual transfer application submitted earlier may be cancelled and his option be considered for "CG" only.

Now, therefore, the allocation of Shri PK Jain working with MPEB as JE (Gen.) as on 01.11.2000 to CG/ CSEB is confirmed.
