The Tentative Final Allocation List (TFAL) for the cadre of AE (TBPS)/ JE (T&D) working with MPEB as on 01.11.2000 was issued vide Notification (a) referred above. In the said list, the State "OPTED" & "ALLOTTED" in respect of Shri A.K. Gupta (S.No.160) was mentioned as "MP". As no representation was received from Shri Gupta against the allocation shown in the said TFAL, Final Allocation Order was also issued accordingly vide Notification (b) referred above.

Shri Gupta subsequently made a request that he has opted for "CG" and not "MP", and, therefore, may be allocated to "CG". He could not make representation against allocation shown in TFAL because of lack of information due to his remote posting. On verification of record, it has been found that Shri Gupta has indeed submitted option for "CG" and not "MP" and the details mentioned in Final Allocation order are due to typographical error.

Now, therefore, the aforesaid typographical error stands corrected and the entries in "OPTED" and "ALLOCATED" columns in respect of Shri A.K. Gupta (S.No. 160) be read as "CG". Shri Gupta, accordingly stands allocated to CG/ CSEB. The delay in submission of representation is also condoned.
