Smt. Neelmani Panchari, working with MPEB as Staff Nurse as on 1.11.2000 submitted a representation to the Committee that as the services of her husband, Dr. HL Panchari, Sr.Medical Officer are allocated CG/CSEB, she may also be allocated to CG/CSEB. . Smt. Panchari was given due opportunity to appear before the committee.

As Smt. Panchari did not appear before the Committee, her representation was considered in absentia. The committee observed that Clause No. 5.2 of the "Procedure of Allocation" provides that in cases where both husband & wife are working with the Board, both of them will be allocated the same State which is allocated to the officer/employee senior amongst the two. Dr.HL Panchari working in senior cadre amongst the two as on 1.11.2000 has already been allocated to CG/CSEB as per his option. The allocation of Smt. Neelmani Panchari also to CG/CSEB, therefore will be in accordance with the "Procedure of Allocation" and principles of equity & Justice.

Now, therefore, in accordance with the reasons recorded in her case the Committee decides to allocate Smt. Neelmani Panchari, Staff Nurse, to CG/CSEB.
